My Dear Mr. Masani,

I am sending herewith my Itinirary for the World Tour. I am afraid, I will be late by about a fortnight for the Parliament. During my tour, I would like to meet some of the people associated with international liberal movement and will be grateful if you could kindly send their addresses. I am flying day after tomorrow.

✓ I thank you very much for the Central Office's offer for printing the CBI Report and our speeches in Oriya. We fully utilised the exposure of the Congress Ministry in Orissa during the Keonjhar Bye-election.

In the last ^{general} election, we polled 28% of the votes but got our candidate elected as there was a division of votes. In the Lok Sabha election in that Assembly Constituency, we lost by about 2,000 votes. This time we polled more than ~~55~~ 65% of the votes. This is a definite improvement especially when we are pitted against the Raja's influence and that of his Uncle Shri Chhotrai sitting M.P who actively propagated for the Congress. This time we are confronted with a new technique of the Congress. 120 jeeps were arranged by the Congress party at the average of 3 jeeps per booth. These jeeps came from Mine owners, liquor contractors and from Government sources also. The block jeeps were not withdrawn even though the Minister assured in the Lok Sabha to withdraw the block jeeps during elections. These three jeeps per booth literally carried all the voters and during transit tore our identity slips, gave them Congress identity slips with Rs. 2/- notes with the promise to pay Rs. 3/- after they cast the vote. But, I must congratulate the Keonjhar voters. They took the money, rode on the Congress jeeps, brought with them their identity slips and

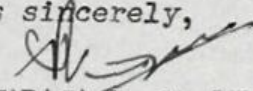
