Decisions taken at the meeting of Swatantra Party Workers
Maharashtra, on Monday, 24th January 1977.

1. No dissolution is called for at the moment. The reason to give is the same as given by other parties viz. that there is no time to convene a convention to decide on the dissolution and all our energies should now be concentrated on strengthening the Janata Party candidates.
2. The National coordinating group of the various opposition parties have hitherto ignored the existence of the Swatantra Party. This could be because of Pileo Mody. Despite this it was felt that the Swatantra Party should not stand on formalities but defacto cooperate by supporting and working for Janata Party candidates.
3. We should also not ask for seats. If any of our members are called upon to contest, only then should we consider doing so.
4. We should try to influence by all means possible the tone of the campaign. While naturally we are highly critical of the assault on civil liberties and on press freedom, this should not provoke us into a personal attack on either the Prime Minister or any New Congress Party leaders by name. Our criticism should be of policies. Positively we should offer concrete alternatives. In other words Swatantra has always insisted on decorum in public life and the eschewing of character assassination. We should use whatever influence we have in persuading our allies to be similarly motivated.
5. Between now and the declaration of results the Swatantra Party workers should speak as Janata Party workers and should not seek to project in any manner the Party's flag or its interests.
6. As for the Maharashtra Swatantra Party workers and units are called upon to voluntarily offer their cooperation to whoever is put up as the Janata Party candidate. The possibility of the Maharashtra Swatantra Party office acting in the name of the Janata Party to monitor criticism levelled by the Congress and providing talking points to Janata Party candidates by way of rebuttal should be considered immediately.
