Dear Sir,

Under instructions from our clients, the Swatantra Party of Maharashtra, we have to address you as under:-

2. Our clients are the tenants of certain premises on the first floor of Sassoon Building, situate at 143, Mahatma Gandhi Road, Bombay-400023.

3. A portion of our clients' said premises was being used by the National Headquarters of the Swatantra Party, of which you were the then President, till August 1974 and for the use of which 40% of the rent and electricity charges were being paid by the National Headquarters of the Swatantra Party to our clients as and by way of - compensation.

4. In or about August/September 1974, a new party known as Bharatiya Lok Dal was formed and of which you became the General Secretary.

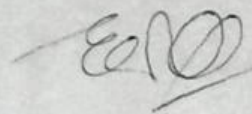
5. In or about September 1974, an arrangement was arrived at between yourself on the one hand and Dr. R.C. Cooper, Shri Parmanand Kejriwal, Shri Girish Munshi and Shri K.H. Subramaniam, whereby it was agreed that you would use the said portion of the said premises, which were formerly used by the National Headquarters of the Swatantra

party and would continue to pay, by way of compensation, 40% of the rent and electricity charges consumed in the premises.

6. We are instructed to state that from and after 1st September 1974, our clients have not received from you the compensation agreed to be paid by you and that such charges from 1st September 1974 till 31st March 1975 amount to Rs.1,628.68.

7. We are, therefore, instructed by our clients to call upon and require you to pay the said sum of Rs.1,628.68 immediately upon receipt hereof by you. Our clients trust that you would not compel them to adopt proceedings for the recovery of the aforesaid amount.
