and MRZ.8939.

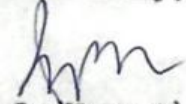
2. Please note that none of these three

these bills, which is a form of harassment which I
hope will now stop.

4. I fail to understand why I am being harassed
in this manner when you have been repeatedly informed
by me that these jeeps belonged to the Swatantra Party
when I was General Secretary way back in the sixties
and that they were sold by the Swatantra Party some
time in the late sixties. The last time I wrote to
you was in February 7, 1984.

5. In order to make sure that you have taken
note of this letter, will you kindly acknowledge
receipt of this letter and confirm that I will not
be harassed further in this matter.
