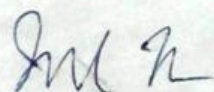
I have just received your communication R.F.No. 7028233 regarding a traffic offence allegedly committed by the driver of Motor Vehicle No. MRA 4024 on 2-11-1979 at 9.10 a.m. The offence in question is No. 8, which is "driving against the police signal".

I am afraid your notice has been sent to me under a misunderstanding. This vehicle is a jeep which belonged to the Swatantra Party at a time when I was its General Secretary and therefore it was registered in my name. This jeep was purchased by Tata Services Limited, 148, M. G. Road, Bombay - 1 and was taken possession of by the representative of the Tata Iron & Steel Co. Ltd. at Bhubaneswar in Orissa on 3rd May 1967, on which day the vehicle was sold by Tata Service Limited to The Tata Iron & Steel Co. Ltd. A copy of the letter addressed to me on March 7, 1975, from the Chief Accountant of Tata Services Limited testifying to these facts is enclosed.

You will thus see that the vehicle in question does not belong to me nor have I any connection with the vehicle or any offence committed by its driver.

In view of this, you will agree it is not possible for me to fill up the form of reply to the traffic offence notice forwarded by you.
