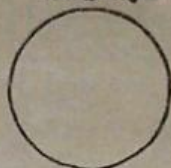

With reference to your above referred communication received by me on the 18th, I note that your letter deals with the recovery of motor vehicle tax due for this vehicle for the period 1-7-67 to 31-11-79. Let me inform you that I have nothing whatever to do with that vehicle.

It was bought on ^{hire} ~~higher~~ purchase for use by the Swatantra Party who were located at 143, N. G. Road, Bombay - 400 023. It was sold by the Swatantra Party soon after the general election of 1967 to Mr. P. K. Dec, Former Maharaja of Kalahandi, Palace, Bhawanipatna, Dist. Kalahandi, Orissa, who was liable to pay motor vehicle tax on the vehicle as from 1967.

You will thus see that I have nothing to do with this vehicle which happened to be bought in my name as I was then General Secretary of the Swatantra Party and on its behalf. You will therefore appreciate that the question of recovering any arrears of motor vehicle tax from me does not arise and I shall be obliged if you will kindly cancel the notice of demand for the payment of land revenue.
