Your postcards Ref.Nos.REW/BOM/MRA.4092/77 and REW/BOM/MRA.4093/77 dated 31st January, 1977, were received in this office only this morning and I hasten to reply.

Vehicle No.MRA.4092 never belonged to me but was one of the vehicles owned by the Swatantra Party of which I was the General Secretary. That vehicle was sold to Maharani Gayatri Devi, Raj Mahal Palace, Jaipur, Rajasthan, in 1967, soon after the general elections of that year. Since then the vehicle has belonged to and been in the possession of the Maharani Gayatri Devi.

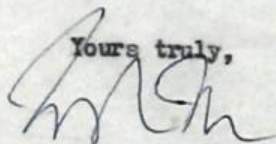
Vehicle No.MRA.4093 was similarly sold by the Swatantra Party in 1967 to Maharaja P.K. Deo, Bhawanipatna P.O., Kalahandi District Orissa, with whom it has been ever since.

I may further mention that I received letter No.RTO/BOM/MRA.4024 etc/75 dated 15th March, 1975, from your office, signed by your predecessor, Mr. P.G. Deshmukh, Regional Transport Officer, (Recovery) Bombay which reads as follows:

"With reference to your letter No.70(a) dated 13.3.1975 I have to inform you that the Collector of Bombay has been instructed to drop the proceeding in respect of the M.Vs. mentioned above."

You will see, therefore that the question of payment of arrears of taxation by me in respect of these vehicles does not arise.

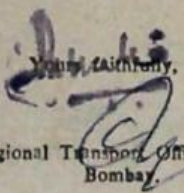

APPEAL AGAINST TAXES:

The time within which an appeal may be preferred under Section 217 of the Bombay Municipal Corporation Act against the Municipal Taxes included in the Bill, or any of them is 15 days after the day of its service.

Payment should be made within a fortnight from the date of service hereof otherwise a notice of demand under Section 202(1) of the Bombay Municipal Corporation Act will be served. If payment is not made or sufficient cause to the satisfaction of the Commissioner is not shown for non-payment thereof within fifteen days from the date of service of notice of demand the amount of tax with all costs of recovery will be recovered by execution of a Distress Warrant under Section 203(1) of the Act. Section 207A further provides a penalty of upto 20 per cent of taxes due if payment is not made within 3 months of service of notice of demand.

PROOF OF PAYMENT: Owners of Vehicles and Animals will please note that for purposes of refund as provided in Section 191(3) a bill-cum-receipt duly discharged will be accepted as proof of payment.

188. (1) Every person who becomes the owner or obtains possession or control of any vehicle or animal in respect of which the said tax is leviable shall give notice in writing to the Commissioner within fifteen days after he has become the owner or has obtained possession or control of such vehicle or animal of the fact that he has become the owner or has obtained possession or control of such vehicle or animal as the case may be.

(2) Every person who ceases to own or have possession or control of any vehicle or animal in respect of which the said tax is leviable shall give notice in writing to the Commissioner of the fact that he has ceased to own or have possession or control of such vehicle or animal. Such person shall be in addition to any other penalty to which he may be liable continue to be liable for the payment of the said tax leviable from time to time in respect of such vehicle or animal until he gives such notice.

Provided that nothing herein contained shall be held to diminish the liability to pay the said tax of the person who becomes the owner or obtains possession or control of such vehicle or animal or affect the prior claim of the Commissioner on such vehicle or animal for the recovery of any tax due in respect thereof.

189. (1) The Commissioner may make an inspection of any stable, garage or coach-house or any place wherein he may have reasons to believe that there is any vehicle or animal liable to a tax under this Act.

(2) The Commissioner may by written summons, require the attendance before him of any person whom he has any reason to believe to be liable to the payment of a tax in respect of a vehicle or animal or of any servant of any such person and may examine such person or servant, as to the number and description of vehicles and animals owned by or in the possession or under the control of such person and every person so summoned shall be bound to attend before the Commissioner and to give true information to the best of his knowledge or belief, as to the said matter.

190. If the tax leviable on any vehicle or animal in respect of any quarter has been paid and if during such quarter such vehicle or animal ceases to be kept within the City or is destroyed or is otherwise rendered reasonably unfit for use or if such vehicle has been under repairs or if such animal has been kept in any institution for the reception of infirm or diseased animals or is certified by a Veterinary Surgeon to have become unfit for use and has not been used, the person who paid the tax leviable on such vehicle or animal shall, subject to the provisions hereinafter contained, and on the Commissioner or any officer authorised by him being satisfied in this behalf be entitled to receive from the Commissioner, if the period in such quarter for which such vehicle or animal has not been kept in the city or has not been used on account of such vehicle or animal being destroyed or rendered unfit for use or on account of such vehicle being under repairs or such animal being kept in any institution for the reception of infirm or diseased animals or such animal having been certified by a Veterinary Surgeon to have become unfit for use is—

(a) not less than eighty days the full amount of the tax paid, (b) not less than sixty days two thirds of the tax paid, (c) not less than thirty days one third of the tax paid. No refund of the tax shall be granted if such period is less than thirty days.

191. (1) No refund of the tax shall be claimable from the Commissioner under Section 190 unless notice in writing of the occurrence of the circumstances giving rise to such claim or of the commencement of circumstances which may give rise to such claim has been given to the Commissioner by the person who paid the tax or his agent.

(2) If such notice is not received by the Commissioner within three days of the occurrence or commencement of the circumstances as aforesaid the period previous to the date of the receipt of the notice shall be excluded in computing the period of eighty, sixty, thirty days referred to in Section 190 for the purpose of granting any refund.

(3) It shall be in the discretion of the Commissioner to disallow any claim for refund of the tax unless application claiming such refund is made to him in writing before the expiry of 15 days after the end of the quarter to which the claim relates and is accompanied by the relative bill-cum-receipt issued to the applicant under Section 200 for the amount of the tax from which the refund is claimed.
