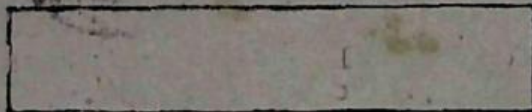

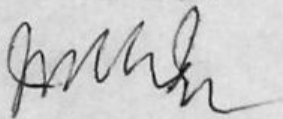
I have received your Bill of Motor Vehicles
Tax No.840201 dated 1.2.1984 for the period February
84 to January 1985 in respect of Jeep No. MRG.2347.

I must confess that I am surprised to
receive this bill as it appears that earlier
communications addressed to you in regard to this
vehicle does not seems to have any effect.

This vehicle belonged to the Swatantra Party
for its use during the elections in 1971 and was
sold by the Party to somebody outside Bombay immediately
after the elections. This information was supplied
to you by the Executive Secretary of the Bharatiya
Lok Dal into which the Swatantra Party merged at that
time, by his letter of March 29, 1976. This vehicle
was No.13 on the list of vehicles mentioned in that
letter. This information was repeated to your office
in a letter dated November 23, 1976, by Mr. S.V. Raju
who wrote on behalf of himself, myself and Mrs. Padma
Vaswani. If you will kindly refer to these two letters
you will appreciate that not only is nothing due to
you from me in respect of these vehicles but that this
bill should not have been sent to me at all. I am
therefore returning the bill for cancellation.

Please note that the arrears are also liable to be recovered as arrears of Land Revenue under the provisions of section 12 of the B. M. V. Tax Act, 1958.

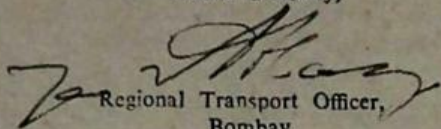
