1. The minutes of the previous meeting held on August 20, 1990 were read and confirmed.
2. The Income & Expenditure Statement and the Balance Sheet for the period ended March 31, 1991 were passed .
3. Matters regarding the premises at 143, Mahatma Gandhi Road, as also the latest position of electricity consumption were discussed and the following broad decisions taken:

- (a) The two Suits No.12/14 of 1990 and No.5857 of 1990 in the Small Causes Court against Ratansinh Rajda and the Afternoon should be continued.
- (b) The Suit No.2452 of 1991 filed in the City Civil Court regarding electricity consumption by the Afternoon should also continue.

It was agreed to honour the interim verdict of the Court regarding sharing electricity charges between the Afternoon and the Swatantra Party, Maharashtra on a 60%/40% basis, as also permission to be given to the Afternoon for taking a sub-meter.

- (c) The arrangement with the Adult Education Institute regarding sharing of electricity charges and monthly donation should continue subject to adjustments made after the Afternoon pays their share of dues.

The meeting then terminated with a vote of thanks to the Chair.
