Mr. Piloo Mody explained the steps he had taken, based on his being authorised by the National Executive to explore the possibilities of bringing several parties together to form a new Party. He felt that in the larger interest of the country, it was necessary to have a new Party to serve as a National Alternative to the Ruling Congress.

Mr. M.R. Masani expressed unhappiness at the proposal of dissolving the Swatantra Party. He did not think the dissolution of our Party would serve the need of a National Alternative and opposed the move of dissolution.

Mr. Madhu Mehta appealed to the members not to pass the Resolution as proposed by Mr. Parmanand Kejriwal. However, majority of members insisted the resolution to be put to vote. The following Resolution was then passed with an overwhelming majority with one dissenting vote from Mr. N.K. Jagtap.

Moreover, with opposition parties like the Congress(O) and the Jan Sangh continuing their individual existence, the objective of a two-party system and its electoral benefits will continue to elude us. On the other hand, there is real danger of the ruling Congress on the one side and the Jan Sangh on the other being the direct beneficiaries of such a development.

The State Council of the Swatantra Party, Maharashtra, does not consider the time or occasion opportune for the disappearance of the Swatantra Party from the Indian political scene, and is, therefore, opposed to the proposal to dissolve the Party.
