Dear Mr. Bhatia:

We understand that the Swatantra Party at the centre will cease to exist as from the 29th August 1974.

The Swatantra Party, Maharashtra had provided office space for the National Headquarters of the Swatantra Party only to further the cause and work of the Swatantra Party. In view of the decision of the Swatantra Party at the centre to cease to exist, that space will no longer be required by you because there will be no National Headquarters of the Swatantra Party in existence. As the premises are meant for the use of the Swatantra Party only we will thank you to confirm by the 26th August 1974 that you will hand over the space allotted to the National Headquarters to the undersigned. We do not desire to permit the use of this space to anyone not connected with the Maharashtra Swatantra Party.

Please treat this, therefore, as a notice calling upon you as the Executive Secretary of the Swatantra Party, National Headquarters and through you the President and office-bearers of the Party to hand over to the undersigned the space which the National Headquarters were permitted to use by the Bombay Region of the Swatantra Party and subsequently by the Swatantra Party, Maharashtra.

Naturally if the Swatantra Party at the centre takes a decision to continue as the Swatantra Party and not to cease to exist, we shall be delighted to permit the National Headquarters to occupy the space allotted hitherto.
