1. The minutes of the previous meeting held on 2/4/1971 were confirmed.

2. Arising out of the minutes, it was decided that in case the election from the Graduates' Constituency to the Maharashtra Legislative Council were postponed from June 71 to September/October 71, then Mrs. Sarla Datar should be our candidate for the said election.

3. As regards the Civic Bye-elections from Borivli area, the General Secretary was authorised to find out suitable candidates for approval by the Parliamentary Board.

4. In regard to various circulars from the National Headquarters Re: minimum programme, Party elections, selection of prospective candidates and constituencies etc., the General Secretary reported that letters have been addressed to all the Units to convene general body meetings of all their members in their respective areas and report back to him.

5. Regarding the Committees' unanimous request to Mrs. Sharayu Daftary to continue to function as the Convenor of Ladies' Wing, the Chairman enquired whether her confirmation had been obtained and if not, to obtain it.

Since the National Headquarters Circular No. 260 intimating appointment by them of a Sub-Committee to review our Party's Statement of Policy and inviting our suggestions has been sent to Primary and District Units, the General Secretary was asked to circularise it only to members of Regional Council and the Executive Committee.

6. For the purposes of Party elections, the General Secretary was asked to select Returning Officers for conducting the elections and then report back.

With a vote of thanks to the Chair, the meeting terminated.
