21 MINUTES OF THE MEETING OF THE EXECUTIVE COMMITTEE, SWATANTRA PARTY,
BOMBAY REGION, HELD ON WEDNESDAY THE 26th November 1969.

A meeting of the Executive Committee of Swatantra Party, Bombay Region, was held on Wednesday the 26th November 1969 at 6-15 P.M. when the following members were present :

1. Mr. Shantilal Thar (Chairman)
2. Mr. R. V. Murthy
3. Mr. Shashikant Gavaskar
4. Mr. M. K. Damlev
5. Mr. P. S. Korpikar
6. Mr. S. R. Pendse
7. Dr. F. S. Noorani.

The minutes of the previous meeting held on 5th November, were confirmed.

2. As neither the President nor any of the Vice-Presidents were present at the start of the meeting, Mr. P. S. Korpikar proposed and seconded by Mr. Gavaskar, Mr. Shantilal Thar was requested to take the Chair. Mr. Shantilal Thar took the chair and conducted the meeting.

3. As regards the receipt of advertisements for the 10th Anniversary souvenir, the office-secretary reported that follow up work was being undertaken in connection with letters rosted to various advertisers; one more advertisement was received in the last week.

4. Regarding Party elections, Mr. P. S. Korpikar reported about the communication received from Dr. R. C. Cooper, Acting General Secretary of All India Swatantra Party, that as the Bombay North East District had failed to avail of the opportunity in time, they had lost their right to elect their representatives on the Regional Council and thaty they could be coopted by the newly elected Regional Council after the Party elections were over. The General Secretary also reported that the first meeting of the newly elected Regional Council had been fixed on 2nd December 1969 to be presided over by Mr. M. Patel, duly appointed Returning Officer of the National Executive to conduct the election of office-bearers, members of the executive committee and 9 representatives on the All India General Council.

5. Regarding the appointment of the Enquiry Committee to enquire into the case against Mr. Desmond D'Souza, Mr. R.V. Murthy said that due to preoccupation, he would not be able to be member of the Enquiry Committee. It was, therefore, decided to appoint Mr. S. R. Pendse in place of Mr. R. V. Murthy, on the two member committee to enquire into the whole case.

The meeting terminated with a vote of thanks to the Chair.
