On instructions for my client
Mr. K.B. Patel, of 2098, MOTA WAGHSIPARA,
DARIAPUR, Ahmedabad, I give you
this notice to inform you that :-

- (1) My client is at present working as
the General Secretary of Mehsana Zilla
Sw. Party, and he is also a member
of the State Council. Before that he
worked as the office - secretary of
the Ahmedabad office of Gujarat
Sw. Party for about $2\frac{1}{2}$ years ending
November 1967.

(2) At the time my client was the office secretary of Ahmedabad office of Gujarat S.W.P., during that period, my client spent, from his own pocket, an amount of Rs. 5034 = 37 p for the party's sake, under unusual circumstances, and this fact is known to the then joint secretaries of the party viz Mr. Jashbhai Patel and Mr. Narasimhaiah Thada and also Mr. A.K. Desai and Mr. Raval.

(3) My client had written many letters demanding the amount of Rs. 5034 = 37 p from the (Sw) Party, met personally, but in spite of that the office-bearers of the party have not given any satisfactory reply, and thus have shown negligence towards the just demands of my client, and therefore after many

requests, out of ~~the~~ my clients
 demands of Rs. 5034-37 p, a sum
 of Rs. 500, say rupees five hundred
 were paid to my client on 16-4-68
 on the orders of the party's treasurer
 at Vallabh Vidya Nagar. My client
 is not a rich man and in spite of that,
 by keeping ~~in~~ full faith in
 Party's office-bearer, ~~and~~ had spent
 his own monies towards party's
 activities with the intention that the
 party's work should not suffer
 because of lack of funds and until
 such alternative funds were available.
 When such situations arose my
 client spent his own monies to
 the extent of Rs. 5034-37 p, which
 after deducting Rs. 500/- now comes
 to Rs. 4534-37 which amount is
 due to my client.

(h) In this connection I wish to draw your attention to the letters my client had written and because the correspondence was ignored, my client has been compelled to give this notice.

(5) Therefore, by this notice, you are informed that within 15 days of the receipt of this notice if my clients dues are not paid or if any arrangement is not made to pay the dues of Rs. 4534 = 37 p, and if no satisfactory answer is received by my client, then my client will have no alternative but to take action against ~~you~~ the party, as legally advised.

This notice has been served upon you in your capacity

party, past and present.
