

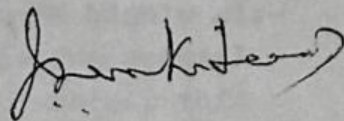

The Committee discussed at length the letter dated September 14, 1994 from the Election Commission of India in reply to our letter dated June 28, 1994 which in effect amounted to a negative reply as the reply insists on our adhering to Section 29A which means swearing by socialism. In this connection it was decided that the Party should seek legal redress and file a writ petition on the ground that asking us to swear by socialism which we have sworn to oppose was illegal.

In this connection the following resolution was passed:
