Moscow was a great improvement on Leningrad. Here, instead of empty buildings, was a housing shortage with which the feverish building programme of the Moscow Soviet was unable to cope. The popular figures of the new capital continued to soar and rationing of house space has had to be resorted to with a governing principle of "need, not greed."

The streets of Moscow were well looked after, and there was much more traffic. One is not left to the tender mercies of the 'izvoschik' because there are taxi-cabs with reliable metres and rates not above the Bombay level. Most of them belong to the City Soviet, the privately-owned cars being distinguished by a yellow band all round - the idea being that good citizens should give preference to communal cars. Besides trams, there ^{are} Leyland omnibuses newly imported from England. As we drove to our destination in two taxis, we were struck by the unbroken line of huge buildings. We even saw a sky-scraper after the American model which we learnt was the office of the State Sugar Trust. Later we saw more of these sky-scrappers being built.

The hotels in Moscow were a relief after those in Leningrad, being all that one is accustomed to look for in Western Europe. This pleasant experience was also repeated in Nejni-Novgorod and Kiev.

A Workers' Rest Home.

Of the many institutions we visited during our feverishly busy ten days in Moscow, I must touch upon just a few of the most interesting. And as we were struck most with the wonderful social and cultural work of the Soviet Government, I shall start with the Kalinin Rest Home at which I spent one of the most pleasant days of my trip. It was started in 1920 on the estate of an aristocrat, an hour's train ride from the city. The beautiful mansion is now used as a club house and the three hundred acres of land around is dotted with thirty six cottages housing eighteen thousand workers on their holidays and with extensive sports grounds. A big open-air theatre was being built under the supervision of Strislavsky's own father! This was a coincidence, but symbolic of the way in which the best of the Old Order is co-operating enthusiastically in the construction of the New. We went through the cottages - clean, airy rooms - window

all through the summer 'By Order' - four or five beds in each. We had our dinner in one of the three huge refectories. We found this practise of inviting ourselves to dinner 'without giving notice' desirable from more than one point of view ! We never had a meal in any of these working-class homes any less wholesome or tasty than the fare in the best hotels. But while the work paid only thirty five Kopoks(Sannas), we had to pay about two or three roubles (3 or 4 rupees.)

There was a great demand for books at the Rest Home, and to meet it there was a fine library of hundred thousand volumes. Of translations of foreign writers, I found the most popular to be those of Upton Sinclair, the American Socialist. Rabindramath Tagore's works were there too. I received a request for a volume of Sarojini Naidu's poems from a journalist who could read English.

Indian Students In Moscow University.

To me personally the most interesting part about my visit to the Rest Home was the presence there during their vacation of three hundred Chinese Students from the Sun-Yat-Sen University and a smaller number of Indian, Malayan and Negro students from the Oriental University. They were mostly studying politics and economics - Marxian, of course. One of the Chinese students who had got ~~the~~ a Doctorate at the London School of Economics was "finishing" his education before going home. All the students I talked with were happy and enthusiastic. They were given free board and lodging, and a little pocket money 'according to their needs.' A Malayan student told me he drew only half his allowance "You see, I don't smoke like the others." A West Indian from Jamaica told me, how - despised over the rest of the globe - the 'Black men' was received in Russia as a comrade. "Colour or race prejudice," he told me, "even among the ordinary uneducated people ~~simply~~ simply does not exist. My colour is regarded as a badge of comradeship. I don't need to show my Communist Party Card." So too an Indian. "In Moscow you can forget your race, in London you just can't."

"The Childrens Republic".

In the Press outside Russia, reference is generally made to poor, neglected homeless children starving in the streets as a consequence of the Revolution. The woeful condition of these children is the natural result of the disastrous war and of the succeeding years of famine and blockade. To-day, there are still ab

nine hundred of them on the streets of Moscow, but over five thousand have already been ~~in~~ placed in nine institutions round about this city. We went to one of these places of "neglect", an hour's journey from town. In outward appearances, it was very much like the Home of the "Society for the Protection of Children in Western India" in Matunga, but the ideas and principles on which it was run were of a far more progressive kind as can be seen from its name - the "Children Republic." Besides providing the house and school for three hundred children only one per cent of whom have parents, the Childrens Republic is an experiment in which the children are given the fullest imaginable liberty and self-government. In order, however, to give this experiment a chance of success, only the ~~best~~ ~~of~~ better type of children found homeless are sent there. The older and more hardened types were sent to institutions more reformatory in character.

The courses at the Childrens Republic included the ordinary school curriculum, agriculture, carpentry, shoe-making and book-binding. The system of teaching described ~~to~~ as "the laboratory system" are emphasised. The idea of leaving children to find things out for themselves and of cutting lectures and classes down to the minimum. The staff was very highly qualified - quite half the instructors having undergone a four year pedagogical course at the University. The children were allowed the fullest liberty, the doors being open day and night, and yet ~~the~~ headmistress proudly told us that not one child has attempted to run away. And I wasn't surprised. The conditions were ideal, they had all the little comforts they could think of and besides it was 'their' republic. When they talked to us, it was always "Our" republic our school . . . Have the Indian children theirs?" The Republic which was under the Commissar for Instruction, was managed by the Board composed of the staff of five children, meeting in sessions open to all the children. Besides, there was a Pupil's Committee elected by them thrice a year. These "neglected waifs" appeared to us very intelligent and well-informed. In fact, one of the ladies in our party thought them a little precocious !

People's Court.

One morning we paid a visit to the People's Court in our ward of the city. It corresponded to an amalgamation of the Presidency Magistrate's Court and the Small Causes Court. But even in this court of summary procedure there are

two assessors - ordinarily ^{factory} ~~factory~~ workers - who together with the Judge, for the Court. A majority verdict being necessary, they can even overrule him or ~~her~~ her. The Judge in this case, was a woman. She was not a lawyer, but an ordinary worker elected by the local Soviet for a term of one year, but eligible for re-election unless there was something against her. The legal element was represented by the Public Prosecutor, who was appointed by the Commissar for Justice ~~and~~ and thus represented the Executive. Besides his ordering duties, he was specially charged with protecting persons who are illiterate or otherwise at a disadvantage.

The position of the lawyer under the Soviet 'regime' is a peculiar one, because he has responsibilities towards the State from which the lawyer in the other countries is free. The pleader does, of course, act for his clients and charge his ~~about~~ own fees.
