Sir,

We were glad that gave a lead to all those who did not like the merger of Swatantra party with the proposed B.C.D.

We could not attend the Delhi convention owing to certain inconveniences. We are taking steps to call a meeting of State council members and important workers of the party in Karnataka on the 18th (Sunday) instant, at the office of the State unit of the party to explain to them the disadvantages of merger and the way in which the Delhi convention was conducted. A copy of the meeting notice (in Kannada) is enclosed herewith.

It was a serious error on the part of Mr. Piloo Mody to have taken steps to dissolve Swatantra when other smaller parties which are to merge have not yet dissolved themselves. Five State units of our party have opposed merger and have ~~declared~~ declared that they would retain the name, flag and symbol of Swatantra. Efforts are being made by some of us here to keep the Karnataka State unit also intact. Under these circumstances we request you to take suitable steps to bring about a liason between the various State units which do not want merger. We also request you to keep us informed about the steps which you may take in this regard.

Long live Swatantra.
